COMMISSIONER FERREL BONNER ANNOUNCES CANDIDACY FOR FORT BEND COUNTY JUDGE

FORT BEND COUNTY, JULY 7, 2025 – Commissioner Ferrel Bonner has officially announced his candidacy for Fort Bend County Judge.

Ferrel currently serves as Commissioner, Fort Bend County Emergency Services District 7 (FBCESD7), providing health, welfare, emergency, and medical support to 35,000 residents, within a 37 square miles radius. He is a Husband, Father, and Grandfather who has resided in Fort Bend County for the past 21 years.

Commissioner Bonner was raised in the inner city of Houston, where he learned early that the key to success was understanding hard work, being consistent, the importance of education—studying hard and never giving up. This belief has shaped everything he does. He believes that we have a moral obligation to assist those who cannot help themselves. Every person deserves dignity and respect.

Throughout his life, he learned the value of leadership, teamwork, and common-sense solutions to everyday problems. His career spans well over 41 years of military service, civil service, political, and grassroots advocacy experience.
